- 4. Approve vouchers, including Excise tax
 - Motion to approve vouchers in the amount of \$4,054.07. Tina, 2nd Pat. Unanimous
- 5. 2024 Signature Authorization for the County Treasurer
 - All 5 commissioners signed the document
- 6. Reports from County Commissioner & County Sheriff
 - Asa Leckie Speeds signs will be in later this spring. Alex from the county will come and
 give us a report on how to write the "lodging tax" grant. We are paying for a state
 lobbyist as a county (this should help with being awarded an RCO grant).
- 7. Action items:
 - Appointment of UPRD Commissioner to fill vacancy
 - Ivy Carpe was nominated at the February Meeting. It was asked if there were any more nominations/volunteers that would be interested in playing a roll on the board.
 - Tina Gallion has nominated Walter Johnson.

- 2. Lisa Brown has nominated Jo Runyon
 - Motion to vote this evening to appoint a 5th commissioner to the Parks district. Pat, 2nd Tina. Unanimous
 - Ivy has earned 3 of 4 votes. Ivy Carpe is now Commissioner #3 of the Underwood Park and Rec board.
 - County Commissioner Asa Leckie administered the Oath of Office.
- Renting out our Community Kitchen, discussion / decision Discussion on renting out the
 kitchen to small businesses. It was discussed that we would really like to help small/start
 up businesses, but we have a few concerns. 1. We have a Levy that is needing to be voted
 and passed on by the community. This community center is not promised to be around
 next year if we do not have a tax levy. 2. These small businesses do not fall within our

mission and vision statements. 3. We don't have the extra space and expense for the needed storage.

- Motion to defer renting out the Community Center kitchen until after the November election Levy results. Pat, 2nd Ivy. Unanimous
- Facility Manager compensation We will table this discussion for the next meeting.
- Restrooms remodel We have received a reasonable bid with a local licensed contractor.
 The board met with this contractor prior to the meeting. The bid we received was \$28,800.
 - Motion to approve contract with some minor adjustments to the price and plan not to exceed \$36K. Tina, 2nd Ivy. Unanimous
